FIRE CHIEF REPORT

Fire Chief Billy Ford, III gave the following report:

- 1) He requested that Amy Mendenhall be reimbursed for CPR cards she certified for township EMT's.
- 2) The "auto-response" document for Paint Valley Schools between our department and Paxton Township/Bainbridge is still being worked on.
- 3) The current response document in place with Union Township for the eastern end of the township will be reviewed before the end of the year. The way the document is written is the same as "mutual aide" but we pay them \$800.00 per year for the agreement. The written document needs to be an "auto response" document.

Amy Mendenhall is requesting permission to run with Paxton EMS. The Chief recommends the Trustees approve the request. *Motion* was made by Mr. Whitt and seconded by Mr. Bethel to approve the request. All voted yes. Motion passed.

4) Fireman Vic Wright reported that the owner of Atomic Speedway would like to purchase the township's old extrication tools. Mr. Bethel told the Chief to be sure the township has no use for them before committing to sell the equipment.

1. The Fiscal Officer reported:

At the Ross County Township Association meeting held in September, the Ross County Planning Department reported on a grant currently available that can be used to demolish abandoned structures at no cost to the homeowner.
